1. Abstract

GATCO aims to position itself as a next-generation **DEX** combining simplicity, scalability, and strong community governance.

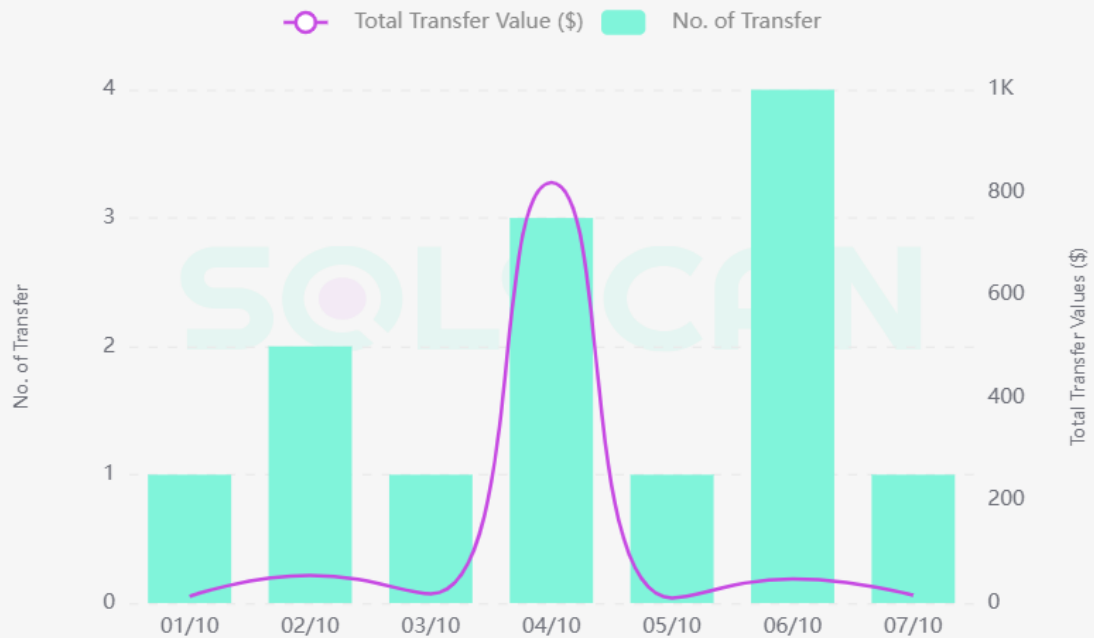

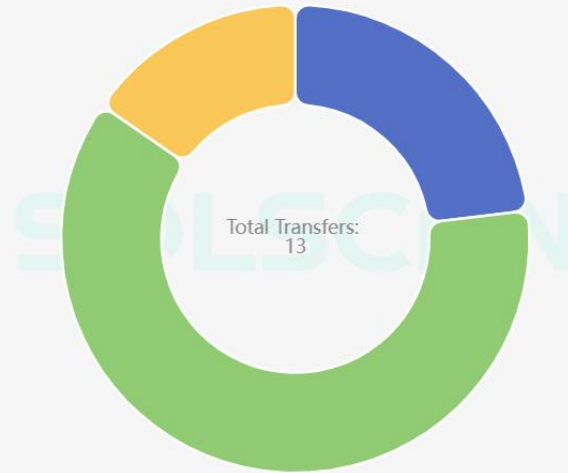
Token Distribution By Value Transfer

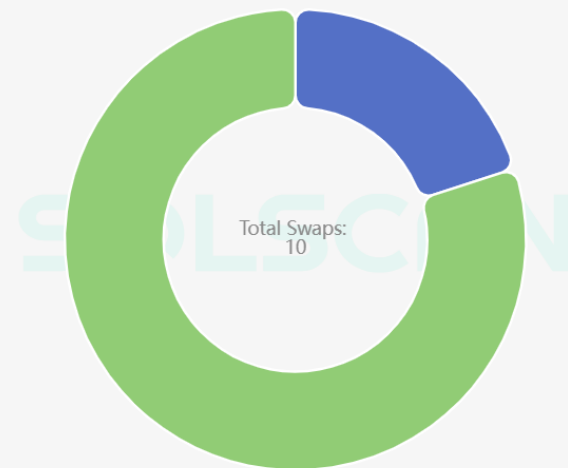
